**Introduction of new Economic Development Coordinator** – Karl Paulsen introduced himself and shared his background with the group.

**Economic Development Overview** – Laura Lewis Marchino, Executive Director, Region 9 Economic Development District of Southwest Colorado

Laura Lewis Marchino gave an enthusiastic and informative presentation on Rural Economic Development. She spoke about how much more challenging economic development is in rural areas. She defined economic development and explained how it is accomplished.

attempt to identify the overlap of projects sponsored by Regions 10 and 12. The meeting goal will be to identify gaps in the AGNC region; any plans to currently being made to address those gaps and to tee up continued conversation regarding AGNC's role, if any, in addressing those gaps.

**ED Summit** – Staff plans to host an Economic Development Summit in August 2021 in Rifle at the Ute Theater.
