Called to order 11:00am

EDD Update – Mistalynn Meyeraan presented a update on the AGNC EDD via PowerPoint. She presented the key accomplishments and initiatives for Q4 2025. She spoke about childcare issues in Western Colorado including the closing of a vital childcare business in the region. She said that information was given to the AG’s office to investigate the closure. Mistalynn spoke about the RPI Grant for the Northwest Colorado Outdoors Alliance in Moffat and Rio Blanco Counties. She spoke about the work that AGNC does for the grant and that it is considered in-kind matching for the grant. She presented a deliverables update from Jon Miller and Kari Brennan on the grant. She presented survey results for the grant. She then presented updates to EDA funding including that EDA funding can be used as a match for USDA and CDS funding. She spoke about the Assistance to Coal Communities applications that will be due June 1st. She then presented on the regional CEDS requirement for AGNC to keep its designation as an Economic Development District. She said the CEDS are required to be updated every 5 years, and the rewrite is due in September. She presented the map of the AGNC EDD. She spoke about why it matters to northwest Colorado. She spoke about the need for CEDS and that it is federally regulated and requires 5 core elements. She spoke about required content including economic analysis, strategy and action plan, and economic resilience. She spoke about AGNC’s role as the EDD for the region. She then spoke about the EDA investment priorities. She spoke about what to expect during the 2026 CEDS rewrite and participation from the region, AGNC board of directors, members and associate members. Tiffany Dickenson asked for participation from the region.

Next EDD meeting will be May 20, 2026, in Rifle.
